What is the overall <u>deductible</u> ?	\$0 Benefits are administered on a calendar year basis.	See the Common Medical Events chart below for your costs for services this <u>plan</u> covers
Are there services covered before you meet your <u>deductible</u> ?	Yes: <u>durable medical equipment</u> , <u>emergency room care</u> , <u>emergency medical transportation</u> , prescription drugs, outpatient mental health services, <u>preventive care</u> , <u>provider</u> office visits, <u>rehabilitation services</u> , <u>habilitation services</u> , routine eye exams, are covered before you meet your <u>deductibles</u> .
