
# Act now to continue to care for your current Tufts Health Together MCO members in 2026



As of Jan. 1, 2026, the Tufts Health Together MassHealth MCO will no longer be offered. In order to continue seeing patients from this plan as their primary care provider, you'll need to complete the actions noted below by May 30, 2025.

## **Options for 2026**

### There are two paths for your practice depending on your current MassHealth health plan participation.

Please note that any new practice affiliations, provider contracts, and member re-assignments will be effective on Jan. 1, 2026. MassHealth intends to assign current Tufts Health Together MCO members to the MassHealth managed care plan that their primary care practice decides to participate in as of Jan. 1, 2026. Members will be receiving further information about their future plan assignment and will also have the option to choose a different plan if they desire to do so.

## Practices that currently participate in the Primary Care Clinician (PCC) Plan or the WellSense MCO and wish to continue

- Your practice may continue to contract with the PCC plan and/or WellSense Essential MCO.
- As is the case today, you may contract with either or both the PCC Plan and WellSense Essential MCO but, if you contract with either or both, you may not contract with one of MassHealth's Accountable Care Organizations (ACOs).

#### Practices that would like to be in a new MassHealth Plan

• To continue seeing your Tufts Health Together MCO members after Dec. 31, 2025, your practice will need to participate in a MassHealth ACO, MCO, or the PCC plan starting Jan. 1, 2026.

### Action needed:

- **Review your options:** Begin by reviewing the 2025 MassHealth Enrollment Guide located at <u>www.masshealthchoices.com</u> under "Member Materials" for information about MassHealth health plans.
- Indicate your interest in the survey: Please note your interest in joining MassHealth's ACO, MCO, or PCC plans in the survey. It's important to note that this is for informational, planning purposes only. You will need to work with the ACO, MCO or MassHealth PCC plans directly to become contracted as a participating provider.

- To contract with a MassHealth ACO or MCO: Please contact the health plans directly to begin discussions. The table below offers points of contact. If you choose this option, you must enter into a contract with that ACO or MCO prior to May 30, 2025. The ACO or MCO will be responsible for notifying MassHealth of the addition of your practice no later than May 30, 2025.
